During the fiscal year, Habitat completed and sold 8 houses. It generally seeks to build and rehab 12 to 14 homes each year and has completed 223 houses since inception in the Cape Fear region. It sells the homes to pre-qualified, low-income families who have actively participated in the construction process. The new homeowners receive an interest-free loan to finance the purchase and pay it off in the same way as a traditional mortgage.
